V) Deficiencies observed by NCISM : Deficiencies observed by the NCISM, New Delhi as per Paragraphs 12 (i) to (iv) vide letter mentioned in Sr. No. 2 above may please be fulfilled and a copy of letter to be forwarded directly to NCISM, New Delhi with the copy to the University within prescribed period.

Important Note:

- This Conditional Continuation / Extension of affiliation is issued for the A.Y. 2025-2026 subject to the permission of NCISM / Govt. of India / Department of AYUSH, New Delhi and if the permission is declined by the said authorities, this Conditional Continuation / Extension of Affiliation shall be treated as cancelled. The College is not authorized to admit the students for 1st Year of the course until receipt of permission of the NCISM / Govt. of India/ Department of AYUSH New Delhi.
- The admission shall be done through the Competent Authorities only.
